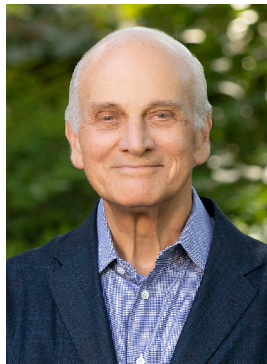
Attendees will learn of the important role philanthropy boards serve and how their work is essential to Providence's commitment to providing world-class health care to communities across the western United States.

Our Presenters

Ed Romano was named vice chairman of Warner Bros. Entertainment in December 2014 and retired in 2019 following a 50-year tenure. Mr. Romano served as Warner Bros.' first vice chairman and worked closely with the studio's chairman and CEO to implement growth strategies for the company including international expansion, digital transition and resource reallocation from mature businesses to high opportunity, content-creating divisions.

Prior to his promotion to vice chairman, Mr. Romano served as executive vice president and chief financial officer for Warner Bros. Entertainment - a post he held since 1994. In this capacity, he was responsible for all financial activities of the company, management information services, studio facilities and corporate real estate. During his time at Warner Bros. Entertainment, Mr. Romano also served as assistant treasurer, controller, vice president and controller and senior vice president and controller.

Mr. Romano is currently involved in a number of industry-related organizations. He serves on the boards of the Academy of Television Arts and Sciences, the Academy of Motion Pictures Arts and Sciences, Notre Dame High School, Providence Saint Joseph Medical Center Foundation, Providence Health and Services Foundation Valley Service Area and the Los Angeles chapter of the American Heart Association.

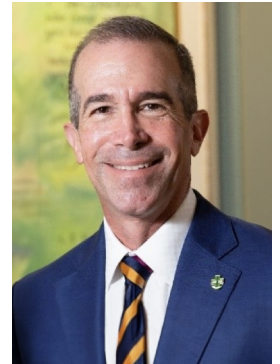

Erik G. Wexler is president and chief operating officer for Providence, leading the Catholic health system's operations across seven western states. Mr. Wexler originally came to Providence Health and Services in May 2016 as regional chief executive for Southern California and worked closely with Providence leadership as it joined with St. Joseph Health. He then served as president of operations and strategy for Providence, leading California, Texas and New Mexico.

In his current role, he is responsible for the operational oversight and strategy for Providence, including 51 hospitals, nearly 1,000 clinics and 120,000 caregivers. Mr. Wexler has been a health care executive for over 30 years with leadership roles at Waterbury Hospital in Connecticut, MidState Medical Center, an affiliate of the Hartford Health System, LifeBridge Health and Northwest Hospital in Baltimore, Maryland. Prior to joining Providence, he served as chief executive officer for Tenet Healthcare's northeast region.

Mr. Wexler earned his bachelor's degree in sociology and master's in business administration from the University of Hartford and holds an honorary doctorate from the Massachusetts College of Pharmacy and Health Sciences. Mr. Wexler sits on the boards of the UCLA Fielding School of Public Health, Tegria, Inc., Providence Ventures, The American Hospital Association Region 9 Policy Board and the Healthcare Advisory Council to the FBI.
